**ARTICLE I - Name:**

The name of the Limited Liability Company is **GOLD CROWN FARMS, LLC.**

**ARTICLE II - Address:**

The mailing address and street address of the principal office of the Limited Liability Company is 1441 Brickell Avenue, Suite 1430, Miami, Florida 33131.

**ARTICLE III - Duration:**

The period of duration for the Limited Liability Company shall commence on the date on which these Articles of Organization are filed with the Department of State of the State of Florida, and shall terminate fifty (50) years from the date of such filing, unless extended by election of the Members, or until dissolved in a manner provided by law, or as determined by the vote of the managers.

**ARTICLE IV - Management:**

The Limited Liability Company is to be managed by one or more managers, and is, therefore, a manager - managed company. The initial manager of the Limited Liability Company is M. Ronald Krongold, whose address is 1441 Brickell Avenue, Suite 1430, Miami, Florida 33131.

**ARTICLE V - Registered Agent:**

The name and the Florida street address of the registered agent of the Limited Liability Company is Krongold & Singer, P.L., whose address is 1441 Brickell Avenue, Suite 1430, Miami, Florida 33131.

**ARTICLE VI - Nature of Business:**

The general nature of the business or businesses to be transacted and which the limited liability company is authorized to transact, in addition to those authorized by the laws of the State of Florida, and the powers of the limited liability company, shall be to engage in any activity or business authorized under the Florida Statutes, and in general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things herein set forth to the same extent as a natural person might or could do.

**ARTICLE VII - Restrictions On Membership:**

Members shall have the right to admit new members by unanimous consent of the members. Contributions required of new members shall be determined by the members as of the time of admission to the company. A member's interest in the company may not be sold or otherwise transferred except with unanimous written consent of all of the members. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates
