#### <u>ARTICLE I</u>

#### NAME AND ADDRESS

The name and principal address of this corporation shall be:

## **ARTICLE II**

#### **NATURE OF BUSINESS**

The general nature of the business to be transacted by the corporation is

#### as follows:

To manufacture, purchase or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise and other personal and real property of every class description whatsoever.

To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said businesses, or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitable dealt with 1 connection with any or the said businesses.
