ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF HAMMOCK PINE VILLAGE I ASSOCIATION, INC. OF SECRETARY OF STATE TALLAHASSEE. FLORIDA

The following is an adopted amendment to the Articles of Incorporation of Hammock Pine Village I Association, Inc., the Articles of Incorporation having originally been recorded at Official Records Book 5314, Page 1251, Public Records of Pinellas County, Florida, as subsequently amended.

(New Wording <u>Underlined</u>; Deleted Wording Stricken Through, Except When Proposed Amendment Involves Substantial Rewording)

Item No. 1: Article III, Section 3.2g of the Articles of Incorporation are hereby amended to read as follows:

ARTICLE III POWERS

The powers of the Association shall include and shall be governed by the following provisions:

* * *

3.2 Enumeration. The Association shall have all of the powers and duties set forth in the Condominium Act except as limited by these Articles and the Declaration of Condominium, and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration and as it may be amended from time to time, including but not limited to the following:

* * *

g. To make and amend reasonable regulations respecting the use and appearance of the property in the condominium; provided, however, that all those regulations and their amendments must be consistent with the Declaration and with the Florida Statutes and other applicable law. Further, the membership of the Association will have the right to veto any amendments to the rules which are adopted by the Board, by a vote of a majority of the membership at any regular or special meeting of the members. shall be approved by not less than sixty percent (60%) of the votes of the entire membership of the Association before they shall become effective.
