# ARTICLES OF ORGANIZATION ·

## PRECISION WRIGHING SOLUTIONS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### ARTICLE I -- NAME

The name of the limited liability company shall be: PRECISION WEIGHING SOLUTIONS, L.L.C. (hereinafter "the Company").

A member may transfer his or her interest in the Company as set forth in any Operating Agreement of the Company, but the transferse shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


