

The undersigned hereby subscribes to these Articles of Incorporation for the purpose of becoming a corporation under the laws of the state of Florida, by and under the provisions of the statutes of the state of Florida, providing for the formation and liabilities, rights, privileges, powers and immunities of a corporation for profit, and I hereby certify:

ARTICLE I

The name of this corporation is SEVEN MOONS PRODUCTIONS, INC.

ARTICLE II

This corporation is organized for the purpose of video production and business related thereto, and the doing and performing of any and all other kinds of related incidental activities thereto, without limitation, and for the purpose of transacting any and all business and engaging in any activity permitted under the laws of the United States and Florida.

ARTICLE III

This corporation is authorized to issue seven thousand, five hundred (7,500) shares of one dollar (\$1.00) par value common stock which shall be determined "common shares" with equal voting rights.

ARTICLE IV

Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of the outstanding common stock.

#### ARTICLE V

#### ARTICLE IX

Seven hundred and fifty (750) shares of capital common stock of this corporation shall be issued initially to JACK VALVO, and seven hundred and fifty (750) shares of capital common stock of this corporation shall be issued initially to NATASHA VALVO.

#### ARTICLE X

The officers of this corporation shall be JACK VALVO as president, vice-president, secretary, director and registered agent, and NATASHA VALVO as treasurer.
