AMENDMENT TO THE

OF

ARTICLES OF INCORPORATION

LOWRY'S REPORTS, INC. (the "Corporation")

WHEREAS, the Lirectors and Shareholders of all the voting common stock of the Corporation, a Florida corporation, did unanimously approve at a meeting of the Shareholders and Directors held on August 31st, 2006, subject only to approval thereof by the Secretary of State, State of Florida, to amend Article III.

NOW, THEREFORE, it is provided that the Articles of Incorporation shall be amended effective as of August 31st, 2006, as follows:

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue FIVE THOUSAND (5,000) shares of common stock, which shares shall consist of two classes:

- (a) TWO HUNDRED AND FIFTY (250) shares of Class A ~ Voting Common Stock, with a par value of One Dollar (\$1) per share; and
- (b) FOUR THOUSAND SEVEN HUNDRED AND FIFTY (4,750) shares of Class B I lon-Voting Common Stock, with a par value of One Dollar (\$1) per share.

Other than voting rights, both classes of common stock shall be identical. No shares shall have preemptive rights. All issued certificates shall bear the legend required by section 607.(-625(3) of the Florida Statutes.
