Pursuant to Florida Statutes 607.1001, the Articles of Incorporation of the above named Corporation are amended as follows:

1. The paragraph of the Fourth Article previously amended shall be additionally amended to read as follows:
2. The number of common shares that the Corporation has issued is herereafter authorized to issue 750,000,000 shares at \$0.001 par value, the specific attributes, as to the foregoing, of which are to be determined, shall be by the Corporation's Board of Directors.
3. The above amendment has been adopted by the Board of Directors of the Corporation entitled to vote thereon by written consent in lieu of a special meeting on Monday, August 16, 2006, pursuant to Sections 607.1001 and 607.1002, as required by the laws of the State of Florida. This action by the Board of Directors does not require shareholder approval.
