**ARTICLES OF INCORPORATION  
OF  
IDI BROTHERS, INC.**

**WE, THE UNDERSIGNED**, being natural persons of legal age, acting as incorporators of a corporation under the Laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is **IDI BROTHERS, INC.**
- SECOND: The period of its duration is perpetual.
- THIRD: The purpose for which the corporation is organized is to distribute baked goods, provide consulting services, and any other lawful business activity within the State of Florida for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1000) shares of common stock having a par value of \$1.00 each.
- FIFTH: The corporation will not commence business until at least One Hundred Dollars (\$100.00) has been received by it as consideration for the issuance of shares.
- SIXTH: Cumulative voting of shares of stock is not authorized.
- SEVENTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional treasury shares of the corporation are none.
- EIGHTH: Provisions for the regulation of the internal affairs of the corporation are governed by the bylaws which shall be adopted by a majority of the directors.

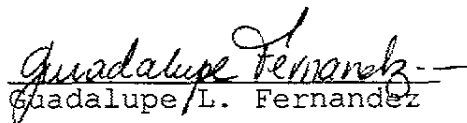
