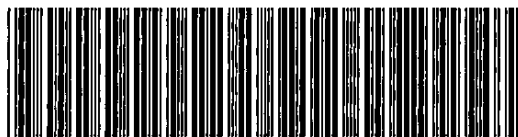

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of

This will be a manager-managed company. The name and address of each manager is:

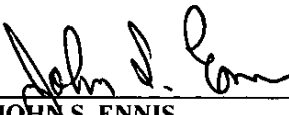
