FOR

(A Florida Limited Liability Company)**

ARTICLE I - Name:

The name of the limited liability company is "TRES G, L.L.C." (the "Limited Liability Company").

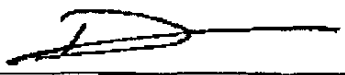
