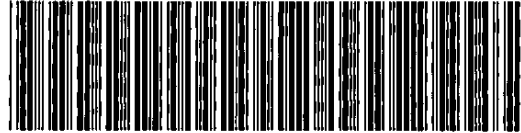

ARTICLES OF ORGANIZATION OF ST. JOHN'S PROFESSIONAL CENTRE, LLC

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I — Name:

The name of the Limited Liability Company is: ST. JOHN'S PROFESSIONAL CENTRE, LLC

ARTICLE II — Address:

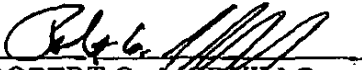
