(c) Conversion of Series C Preferred Stock: Subject to and in compliance with the provisions of this Section 4, any shares of the Series C Preferred Stock, at the option of the holders(s) thereof, may at any time prior to the Redemption Date be converted into that number of fully paid and nonassessable shares (determined without regard to fractional shares) of Common Stock as is equal to the quotient determined by (A) multiplying the number of shares of Series C Preferred Stock to be converted times (B) the Series C Liquidation Preference and then (C) dividing by \$0.0187 (the "Series C Conversion Price" and each of the Series A Conversion Price, the Series B Conversion Price and the Series C Conversion Price shall be known generically as the "Conversion Price") subject to adjustment as hereinafter provided.

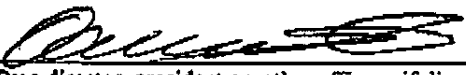
