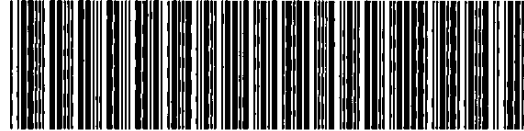

ARTICLE I - NAME

The name of the Limited Liability Company is: **SERENITY INVESTORS, L.L.C.**
