ARTICLE III- DURATION


The duration of this company shall be perpetual and it shall commence on the earliest date of January 3, 2007 or the filing date of these articles of organization.


ARTICLE IV- MANAGEMENT


ARTICLE V- AMISSION OF ADDITIONAL MEMBERS
