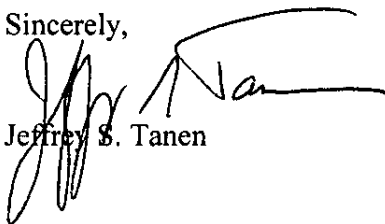

WHEREAS, all of the Members desire to change the name of the Company from 100-248, LLC to 117-268, LLC and have duly adopted such name change;

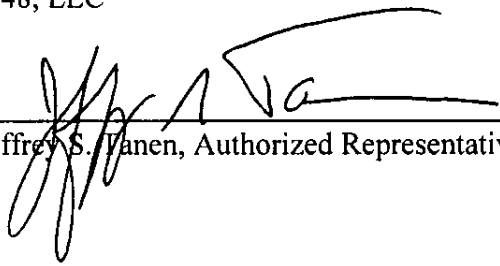
WHEREAS, all of the Members have agreed to adopt this Amendment to the Articles of Organization reflecting such change;
