**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a professional limited liability company for the sole and specific purpose of rendering medical professional services, and further recognizing and agreeing all of its organizers and members shall only be other professional limited liability companies, professional corporations, or individuals who themselves are duly licensed or otherwise legally authorized to render the same professional service as the professional limited liability company to be hereby formed under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621 and the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME


ARTICLE III - MANAGER MANAGEMENT

and REGISTERED AGENT'S ACCEPTANCE**


