



CONSENT ORDER

THIS CAUSE came on for consideration upon a filing of a request by TEMPLETON FUNDS ANNUITY COMPANY (hereinafter referred to as "TEMPLETON") a domestic insurer, with the OFFICE OF INSURANCE REGULATION (hereinafter referred to as the "OFFICE") on or about October 20, 2006, to re-domesticate to Minnesota pursuant to Sections 628.525 and 628.535, Florida Statutes. After a complete review of the entire record, and upon consideration thereof and being otherwise fully advised in the premises, the OFFICE finds as follows:

- 1. The OFFICE has jurisdiction over the subject matter and parties herein.
- 2. TEMPLETON represents that the documents already provided, as well as all pending documents relating to its request to re-domesticate to Minnesota, fully describe all agreements, relationships, and transactions pertinent to the re-domestication, and that all

representations, submissions, documents and explanations made by TEMPLETON in support of its request to re-domesticate are material to the issuance of this Consent Order. Documents still pending shall be provided to the OFFICE within fifteen days of the date Minnesota approves the re-domestication and include (1) Amended & re-stated Articles of Incorporation (2) Certified copy of TEMPLETON'S new Certificate of Authority issued by the State of Minnesota (3) Certificate of Good Standing from the Florida Secretary of State indicating that TEMPLETON is a foreign insurer.

- 3. TEMPLETON represents that its re-domestication will not have an adverse effect on Florida policyholders, and the re-domestication will not affect TEMPLETON's current operations in the state of Florida.
- 4. Upon its re-domestication to Minnesota, TEMPLETON shall become licensed as a foreign insurer as defined in Section 624.06(2), Florida Statutes, and shall be subject to all the provisions of the Florida Insurance Code, applicable to a foreign insurer.
- 5. TEMPLETON shall continue to file its financial statements in compliance with the Annual Statement Instructions and Quarterly Statement Instructions issued by the NAIC, the Accounting Practices and Procedures Manual of the NAIC, and the Florida Insurance Code. All assets and investments of TEMPLETON must comply with the requirements of Chapter 625, Florida Statutes.
- 6. Pursuant to Section 628.530, Florida Statutes, TEMPLETON's outstanding policies shall remain in full force and effect. TEMPLETON may continue to use its existing policy forms with appropriate endorsements, but need not endorse its policy forms solely to reflect its new state of domicile. Furthermore, rates, agents appointments, and licenses in

existence prior to TEMPLETON's re-domestication shall continue in full force and effect after the date re-domestication is approved.

- 7. Executive Order 13224, signed by President George W. Bush on September 23, 2001, blocks the assets of terrorists and terrorist support organizations identified by the Office of Foreign Assets Control of the Treasury Department. The Executive Order also prohibits any transactions by U.S. persons involving the blocked assets and interests. The list of identified terrorists and terrorist support organizations is periodically updated at the Treasury Department's website, www.treas.gov/ofac. TEMPLETON shall maintain and adhere to procedures necessary to detect and prevent prohibited transactions with individuals and entities which have been identified at the Office of Foreign Assets Control website of the Treasury Department.
- 8. The OFFICE and TEMPLETON expressly waive a hearing in this matter, the making of Findings of Fact and Conclusions of Law by the OFFICE, and all further and other proceedings herein to which the parties may be entitled by law or by rules of the OFFICE. TEMPLETON hereby knowingly and voluntarily waives all rights to challenge or to contest this Consent Order, in any forum now available to it, including the right to any administrative proceeding, circuit or federal court action, or any appeal.
- 9. The parties agree that this Consent Order will be deemed to be executed when the OFFICE has executed a copy of this Consent Order bearing the signature of TEMPLETON's authorized representative, notwithstanding the fact that the copy may have been transmitted to the OFFICE electronically. Further, TEMPLETON agrees that the signature of its authorized representative as affixed to this Consent Order shall be under the seal of a notary public.

WHEREFORE, the request by TEMPLETON to re-domesticate, to the state of Minnesota is hereby approved and effective as of the date its re-domestication and licensure applications are approved by the Minnesota Department of Insurance. Should the redomestication not be approved by Minnesota prior to January 1, 2007, this order shall be revoked unless extended or amended.

FURTHER, all terms and conditions contained herein are hereby ORDERED.
