ARTICLES OF ORGANIZATION
OF

The undersigned, being authorized to execute and file these Articles, hereby certifies
that:

Article I. Name. The name of the Limited Liability Company is CCRIM, LLC.

Article II. Address. The mailing address and street address of the principal office
of the Limited Liability Company is 2286 Bruner Lane SE, Fort Myers, Florida, 33912.

Article III. Registered Agent and Registered Office. The name and Florida street
address of the Initial Registered Agent are: Truman J. Costello, Esq., 12670 New Brittany
Blvd. #101, Fort Myers, Florida, 33907.

Article IV. Written Operating Agreement. Any operating agreement (as defined in
Section 608.402(24)) entered into by the members of the Limited Liability Company, and
any amendments or restatements thereof, shall be in writing, and shall govern all matters
relating to the governance of the affairs of the Limited Liability Company, the conduct of its
business and the relation of its members, including without limitation the amendment of
these Articles. No oral agreement among any of the members or managers of the Limited
Liability Company shall be deemed or construed to constitute any portion of, or otherwise
affect the interpretation of, any written operating agreement of the Limited Liability

shall be perpetual, unless the Company is earlier dissolved in accordance with the provisions
of the Operating Agreement or applicable law.

one or more Managers, whose identities and terms of office shall be set forth in the written
Operating Agreement of the Limited Liability Company. The Initial Managers of the
Limited Liability Company are Roger Joseph Matteau and Irene Angela Maj-Matteau.

Article VII. Limitation on Agency Authority of Members. Pursuant to Section
608.4235 of the Florida Limited Liability Company Act, no member of the Company shall
be an agent of the Company solely by virtue of being a member.

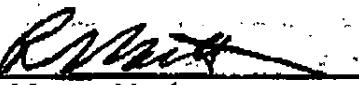

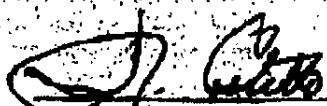
