ARTICLES OF ORGANIZATION OF

ARCALIST AND SOLVED These Articles of Organization are made for the purpose of organizing a Florida Limite Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

<u>ARTICLE I - NAME</u>
