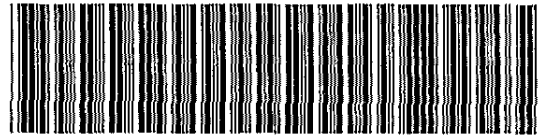

ARTICLE I - NAME

The name of this corporation is Top V. Nails, Inc.

ARTICLE II - PRINCIPAL OFFICE


