

## **ARTICLES OF INCORPORATION**





## BREVARD COUNTY REAL ESTATE COUNCIL, INC.

The undersigned incorporator, for the purpose of forming a not for profit Corporation under and by virtue of the laws of the State of Florida, adopts the following as the Articles of Incorporation of Brevard County Real Estate Council, Inc.

#### **ARTICLE I**

### NAME, ADDRESS, DURATION, REGISTERED OFFICE AND AGENT

- (a) The name of the Corporation is Brevard County Real Estate Council, Inc., hereinafter referred to as "the Corporation".
- (b) The address of the principal office and mailing address of the corporation is 333 Sixth Avenue, Indialantic, Florida 32903.
  - (c) The existence of the Corporation will be perpetual.
- (d) The initial registered office of the Corporation will be located at 333 Sixth Avenue, Indialantic, Florida 32903.
- (e) The initial registered agent of the Corporation at that address is Margaret Babcock Napolitan.

#### ARTICLE II

#### **PURPOSE**

The purposes for which the Corporation are formed, and the business and objects to be carried on and promoted by it are as follows:

- (a) To encourage and promote the use of attorneys in real estate transactions; to foster and cultivate professional relations among real estate attorneys and other real estate professionals in Brevard County; to provide educational opportunities for real estate attorneys; and to promote the understanding by real estate professionals and the general public of the role of attorneys in real estate transactions.
- (b) The Corporation is irrevocably dedicated to and operated exclusively for not for profit purposes; and no part of the income or assets of the Corporation shall be distributed to, nor inure to the benefit of, any individual.

#### **ARTICLE III**

#### **POWERS**

The Corporation is empowered:

- (a) To do all lawful things necessary to carry out the purposes stated in Article II.
- (b) To have all the corporate powers enumerated in the Florida Not For Profit Corporation Act not inconsistent with these articles and appropriate for not for profit corporations.

#### **ARTICLE IV**

#### <u>DIRECTORS</u>

The number of directors of the Corporation and their corresponding Term shall be as provided in the Bylaws; however, the number of directors shall not be less than three. The directors shall be elected as provided in the Bylaws. The directors of the Corporation must at all times be members of the Corporation. The original directors<sub>1</sub> and the terms for which each will serve, are set forth below:

The directors shall serve without compensation.

#### **ARTICLE V**

#### **MEMBERSHIP**

The manner of admission and the grounds for termination of membership in the Corporation shall be as provided in the Bylaws.

#### **ARTICLE VI**

## **OFFICERS**

The Corporation shall have those officers described in, and elected in the manner provided by, the Bylaws.

#### **ARTICLE VII**


