ARTICLES OF INCORPORATION

OF

CLEAN AND CLEAR POOLS, INC.

The undersigned, acting as incorporator of CLEAN AND CLEAR POOLS, INC. under the Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is CLEAN AND CLEAR POOLS, INC.

ARTICLE II. ADDRESS

The mailing address of the corporation is 2941 N.E. 9th Avenue, Pompano Beach, Florida 33064.

ARTICLE III. COMMENCEMENT OF EXISTENCE
