The name of the Company is: **STONE CREEK HEIGHTS, LLC**

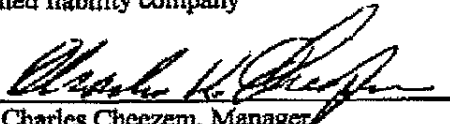
The filing date of the Articles of Organization of the Company was May 31, 2006, under Document No. L06000056133.
