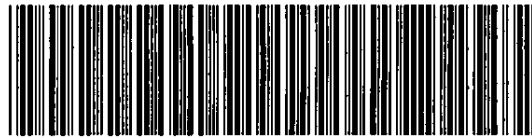

ARTICLES OF AMENDMENT
COASTLINE TIRE AND AUTO AIR, INC.

ARTICLE I - NAME OF CORPORATION

The name of the corporation currently is Coastline Tire and Auto Air, Inc., having been filed on March 13, 1997, and assigned charter number P97000024307.

ARTICLE II - AMENDED NAME

The name of the Corporation shall henceforth be M²D, Inc.

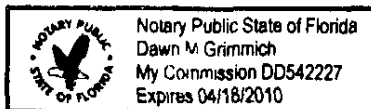
