ARTICLES OF INCORPORATION OF MANY HAPPY HEARTS, INC.

The undersigned, in Compliance with Chapter 617, F.S. for the purpose of forming a non-profit corporation, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: MANY HAPPY HEARTS, INC.

ARTICLE TWO

The term of existence of the corporation is perpetual.

ARTICLE THREE

The purposes for which the corporation is organized are:

- . To promote charitable giving among the general public.
- . To manage and operate fund raising and gift collecting events and to organize, support and sustain recreational and social activities.
- . To bring together people of all ages and backgrounds through gifts and donations to children and the needy.
- . To provide a positive tool for the development of children and the needy.
- To engage in any lawful purpose or purposes not for pecuniary profit.

ARTICLE FOUR

There shall be four members of the initial Board of Directors of the Corporation. The names and addresses of the persons who are to serve as Directors until the first election thereof are as follows:

ARTICLE FIVE

The address of the initial Registered Office of the corporation is 6527 Coral Way, Mismi, FL 33155 and the name of the Registered Agent at such address is JOSE M. GARCIA.

ARTICLE SIX

The affairs of the corporation will be managed by the Board of Directors, which will be elected by its membership in accordance with the Bylaws. The Board of Directors will elect from among themselves a President, a Secretary and a Treasurer. Such Officers will be appointed in accordance with the Bylaws.

ARTICLE SEVEN

ARTICLE EIGHT

The principal office of this corporation shall be located at \$527 Coral Way, Miami, FL 33155, with the corporation retaining the power to move its office to any other address in Florida.

ARTICLE NINE

The Corporation shall have Members. The Members of the Corporation will be required to meet the following qualifications:

Members must be of good personal and moral character to be accepted and to maintain the membership in the corporation.

The Board of Directors shall have exclusive right and discretion to determine whether any applicant or member meets these qualifications for acceptance to the corporation or dismissal from the same.

Persons meeting such qualifications may be admitted upon approval by secret vote of the Board of Directors. Admission requires a majority vote of the Board of Directors.

The Board of Directors may at any time promulgate additional membership requirements not inconsistent with these Articles.

All decisions of the Board shall be final.

ARTICLE TEN

The Bylaws of the Corporation are to be made, altered or rescinded by the Board of Directors of the Corporation.

ARTICLE ELEVEN

These Articles of Incorporation may be amended by the act of the Directors of the Corporation. Such amendments may be proposed and adopted in the manner provided in the Bylaws of the Corporation.
