Informal Action of Members



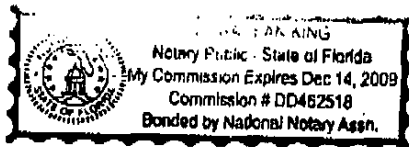

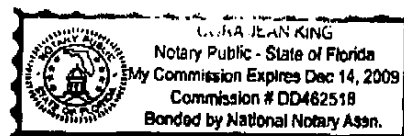
