Article VI be and it is hereby deleted in its entirety and the following Article IV is inserted in lieu therof:

ARTICLE VI. Purpose

- A. <u>Purpose</u>. Notwithstanding any provision hereof to the contrary, the following shall govern: The nature of the business and of the purposes to be conducted and promoted by the Company is to engage solely in the following activities:
