Article VI be and it is hereby deleted in its entirety and the following Article IV is inserted in lieu thereof:

ARTICLE VI.

**Purpose**

A. Purpose. Notwithstanding any provision hereof to the contrary, the following shall govern: The nature of the business and of the purposes to be conducted and promoted by the Company is to engage solely in the following activities:

1. To own the limited liability company interests in 744 Noah, LLC, a Delaware limited liability company, whose sole purpose is to own, hold, sell, assign, transfer, operate, lease, mortgage, pledge and otherwise deal directly or indirectly with the real property, together with all improvements known as Jasper Mountain Highlands Shopping Center, located at 744 Noah Drive, Jasper, Georgia 30143.

2. To own the limited liability company interests in 3545 Canton Highway, LLC, a limited liability company to be formed, whose sole purpose is to own, hold, sell, assign, transfer, operate, lease, mortgage, pledge and otherwise deal directly or indirectly with the real property, together with all improvements known as Chastain Connection Shopping Center, located at 3545 Canton Highway, Marietta, Georgia 30066.
