The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: LOU & MARTHA'S TATTOOS, INC. The principal place of business will be 9952 Gandy Blvd., St. Petersburg, FL 33702.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
