**ARTICLES OF ORGANIZATION**  
**OF**

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

**ARTICLE I**

*Name of Company*

The name of the company (hereinafter the "Company") is Armadillo Holdings , LLC.

**ARTICLE II**

*Address of Company*

**ARTICLE III**

*Registered Agent and Office*

**ARTICLE III**

*Management*

Richard A. Bishop shall serve as the Company's initial Manager until the first annual meeting of the membership or until his successor is elected and qualified; his address is 1650 Canopy Oak Blvd., Palm Harbor, Florida 34683. Thereafter, the Company will be managed by a manager or managers elected annually, as provided in the Company's regulations.

**ARTICLE IV**

*Admission of Additional Members*

Additional members may be admitted to the Company but only if all the current members agree to the admission of the additional members and to the terms of such admission.

### *Termination of Membership*

If a member of the Company dies, retires, resigns, is expelled, declared insane, becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

## ARTICLE VI

### *Registered Agent and Office*

## ARTICLE VII

### *Operating Agreement and Regulations*




