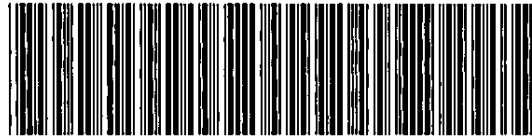

This limited liability company shall exist perpetually, commencing on October 1, 2007.

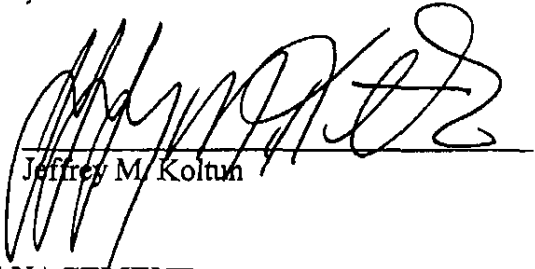

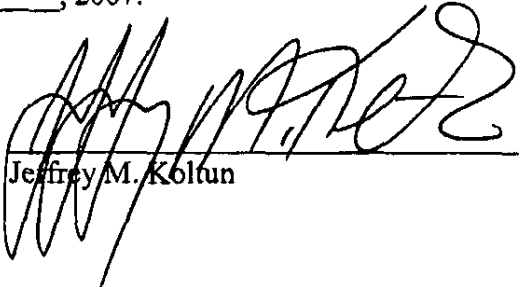
