**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
INTERCONTINENTAL AGENCY, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the above-named corporation, (the "Corporation"), adopts the following Amendment to its Articles of Incorporation:

- FIRST:** The current name of the Corporation is Intercontinental Agency, Inc.
- SECOND:** The Articles of Incorporation were filed on June 16, 1983 and amended on July 24, 1996 and July 22, 1997 and assigned document number G44119.
- THIRD:** The Amendment to the Articles of Incorporation is as follows: Article Four (A) through (C) is to be deleted in its entirety and replaced with the following:

Article Four
Capital Stock

This Corporation is authorized to issue shares of stock as follows:

- (A) The stock of this Corporation will be known as class A common stock.
 - (B) The maximum number of shares of class A common that this Corporation may issue is 27,500.
 - (C) Each share of common stock will have a par value of \$.01.
- FOURTH:** The amendment does provide for a cancellation of shares.
- FIFTH:** The effective date of the adoption of this amendment is September 25th, 2007.
