“The limited liability company is a member-managed company. The name and address of the sole member of the limited liability company are as follows:

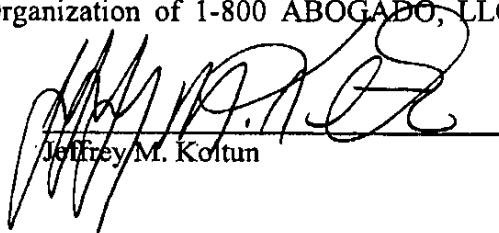
