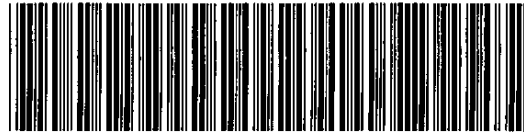

Principal Place of Business

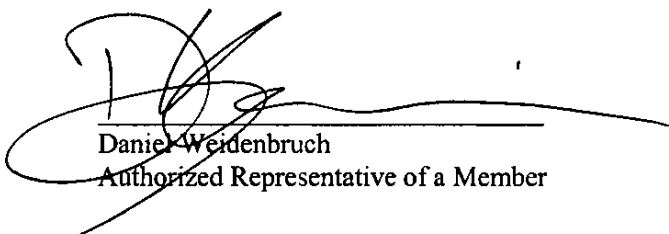
