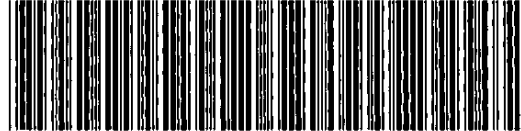

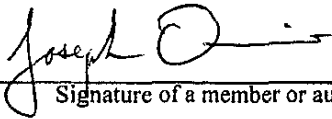
Management of the Company. The Company shall be managed by one or more
