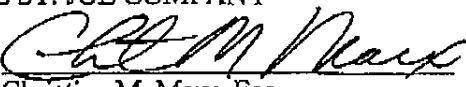

RESOLVED, that the Company shall dissolve its corporate existence effective upon filing Articles of Dissolution with the Florida Secretary of State.

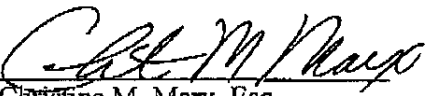
RESOLVED, that the sole member or any officer of the Company shall file the Articles of Dissolution and any terminations of certificates of authority with the appropriate governing authorities.
