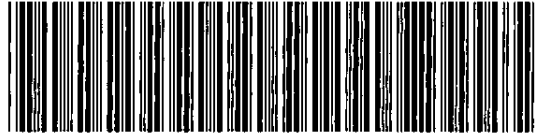

**ARTICLES OF INCORPORATION  
OF

(A Florida For Profit Corporation)**

The undersigned, acting as incorporator to these Articles of Incorporation, hereby forms a corporation for profit under the Laws of the State of Florida, Chapter 607 F.S.

**ARTICLE I – NAME.**

The name of the corporation shall be: TREVER H. MILLS, INC.

**ARTICLE II – PRINCIPAL OFFICE & MAILING ADDRESS.**

The principal place of business of the corporation shall be: 18951 Painted Leaf Court, Jupiter, FL 33458. The mailing address of the corporation shall be: 18951 Painted leaf Court, Jupiter, FL 33458.

**ARTICLE III – PURPOSE.**

The purpose for which this corporation is organized to engage in any activities or businesses permitted under the laws of the United States and the laws of the State of Florida.





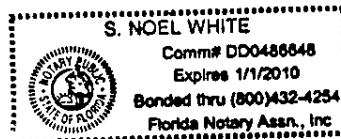
