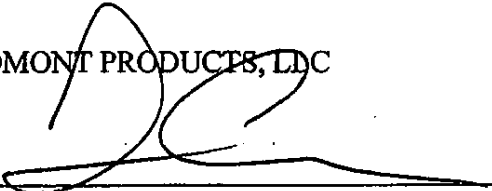
ARTICLE V

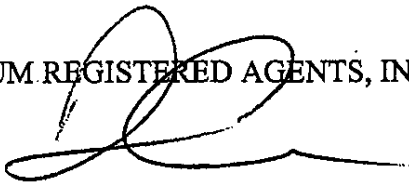
