Pursuant to Section 617.1007 of the Florida Statutes, **PACE ASSEMBLY MINISTRIES, INC.** a Florida not-for-profit corporation (the "Corporation"), certifies that:

1. The name of the corporation is **PACE ASSEMBLY MINISTRIES, INC.**

The original Articles of Incorporation were filed with the Secretary of State of the State of Florida on October 13, 1980.

2. The members of the Corporation duly adopted the following Amended and Restated Articles of Incorporation on December 3, 2007, and the number of the votes for the amendments was sufficient for approval.
3. The Articles of Incorporation of the Corporation are amended and restated to read in their entirety as follows:

ARTICLE I
NAME OF CORPORATION

The name of this religious corporation is **PACE ASSEMBLY MINISTRIES, INC.**

ARTICLE II

STATUS

The corporation is a non-profit religious corporation formed in accordance with the laws of the State of Florida.

ARTICLE III

MISSION STATEMENT

To fulfill the "ETERNAL PURPOSE" of God in Jesus Christ locally and globally - reaching the lost, making disciples, and building the Church of Jesus Christ through the Power of the Holy Spirit.

ARTICLE IV

PURPOSE

The purpose for which this corporation is organized shall be for religious and charitable purposes, including:

- a. To encourage and promote the evangelization of the world;
- b. To encourage and promote the worship of God;
- c. To encourage and promote the edification of believers;
- d. To approve all scriptural teaching, methods, and conduct, disapprove all unscriptural teaching, methods and conduct;
- e. To provide a basis of fellowship among Christian of like precious faith;
- f. To elect its own officers and committees, to arrange for its own meetings and to govern itself;
- g. To establish and maintain such departments and institutions as may be necessary for the pursuance of its work;
- h. To receive tithes and offerings and make investments;
- i. To have the right to own, acquire, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose of, such property, real or chattel, as may be needed for the pursuance of its work;
- j. To do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation and to have and exercise all the powers now or hereafter conferred by the laws of the State of Florida upon nonprofit religious corporations.
- k. To perpetually protect this local church corporation in its

ownership and control of its property and in its sovereignty under Christ therefore, all ecclesiastical power and authority relative to this corporation and its property shall be exercised by this corporation assembled as a congregation.

ARTICLE V **PLACE OF WORSHIP**

The physical address of the corporation's principal office and place worship is 3948 Highway 90, Pace, Florida.

ARTICLE VI **DURATION**

The period or duration of this corporation is perpetual.

ARTICLE VII **NONSTOCK CORPORATION**

This corporation shall be non-stock, and no dividends or profits shall be declared or paid to the members thereof.

ARTICLE VIII **CORPORATE OFFICERS**

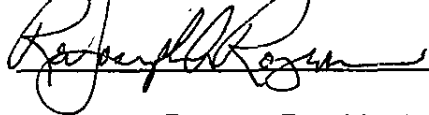

Articles of Incorporation this the 30th day of December, 2007.

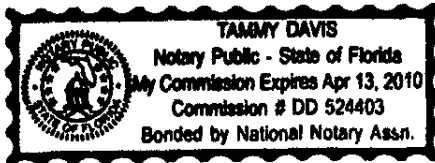
