## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

### <u>SEMINOLE PRECAST MANUFACTURING, INC.</u>

Pursuant to the provisions of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the corporation is SEMINOLE PRECAST MANUFACTURING,
   INC. and the original date of filing/authorization in Florida was December 7, 2001.
- 2. The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation on the 17th day of January, 2008, in the manner prescribed by the Florida General Corporation Act:

Article IV is amended by changing the number of authorized shares of the corporation from 1,000 shares to 1,000,000 shares, so that Article IV, shall flow read:

#### ARTICLE IV. NUMBER OF SHARES

The maximum number of stock that this corporation is authorized to issue is 1,000,000 shares of common stock with \$1.00 par value per share, said shares shall be of the same class without preference.
