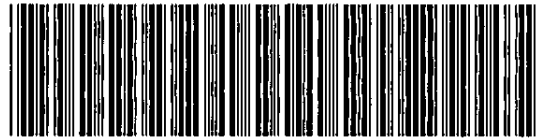

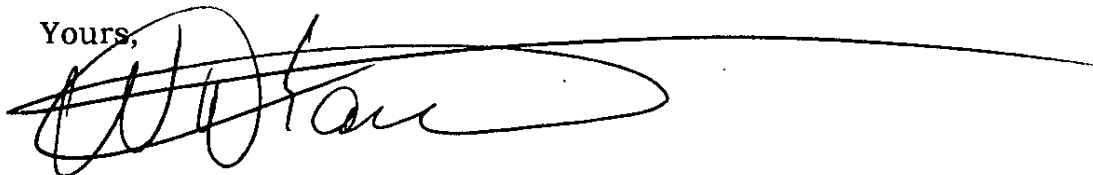

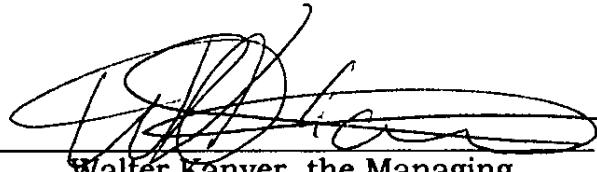
4. Adequate provision has been made for the debts, obligations, and liabilities of the company under Section 608.4421, *Florida Statutes*.
