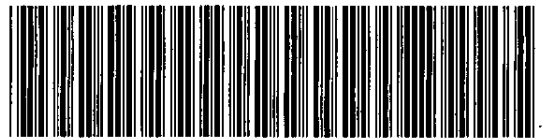

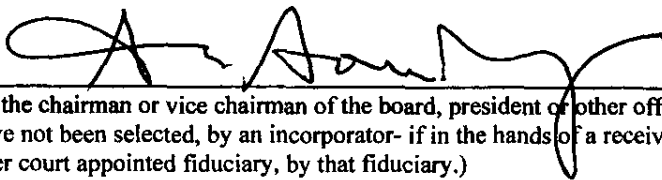

Article VI
Officers, Boards and Committees

The Officers of this corporation shall consist of a President, a Vice-President, a Secretary, who shall be the same person as the Clerk of the Church, an Assistant Secretary, who shall be the same person as the Deputy Clerk of the Church, a Treasurer, and three Assistant Treasurers, together with such officers as the Bylaws may provide and the Church may, from time to time, authorize.

There shall be Deacons, of such number of which shall serve in such functions of service as provided for in the Bible and in the Bylaws.

There shall be Trustees consisting of not more than seventeen (17) members or less than eleven (11) members, of whom shall be the corporate officers designated above.

There shall be a Pastor and such committees as may be provided for in the Bylaws or may, from time to time, be authorized by the Church.

The Officers, Trustees, Deacons and members of committees of the Church shall be elected annually as shall be provided for in the Bylaws, and shall take office as of the first day of January, the Church year being from January 1st through the following December 31st. However, should circumstances require, the terms of the corporate officers shall continue until their respective positions have been filled by duly elected persons. The term of the Pastor shall be indeterminate and shall continue so long as the relationship is mutually agreeable between Pastor and Church. Should any office become vacant, same may be filled by, and upon vote of, the members of the Church.

It is the intent and purpose that this Church shall be, at all times, a pure democracy, with the direction and control in the membership, and that the Officers, Trustees and committees shall function and be subject to the will, direction and control of the Church, whom they shall serve.

A quorum for business purposes shall be not less than 1000 of the members of the Church or such other number as shall be provided in the Bylaws.

All contracts, deeds, mortgages and other legal papers or instruments, as shall be authorized by the Church, shall be executed by the President or Vice-President, joined by the Secretary or Assistant-Secretary of the Corporation. In their absence such other person or persons as the Trustees shall designate, may act pro tempore in his or their stead.

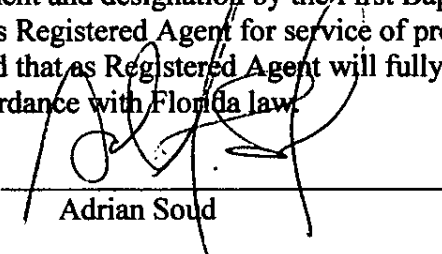
