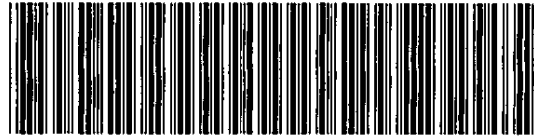

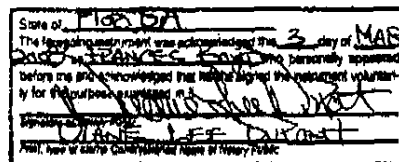
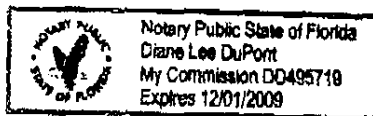

Article 1.

The name of the corporation is Adolescent Life Coaching Center, Inc.

Article 2.

The initial registered office of the Corporation shall be at 853 State Road 436, Suite 133, Casselberry, Florida 32707. The initial registered agent of the Corporation at such address shall be: Frances Boyde.
