The undersigned, for the purpose of forming a limited liability company under the Florida Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles"):

ARTICLE I: NAME

The name of the limited liability company is Ceramic World USA LLC, a Florida limited liability company (the "Company").

ARTICLE VI: EFFECTIVE DATE




