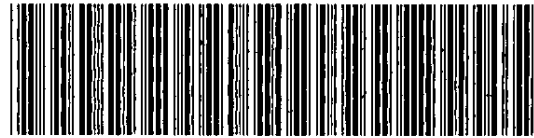

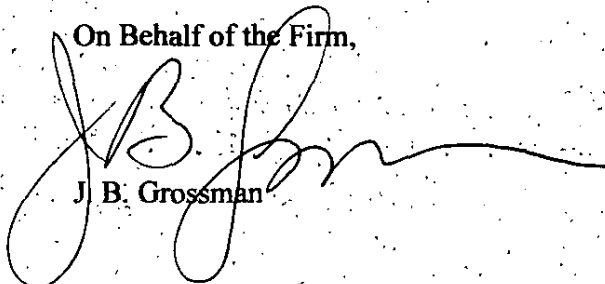
I have done that and the document is retuned under this cover letter.
