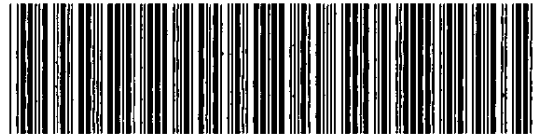

Article III - Purpose

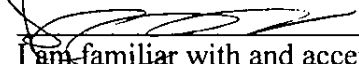
