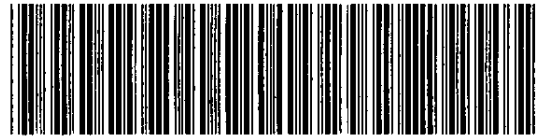


Asset Finders, LLC hereby amends its Articles of Organization and states as follows:
