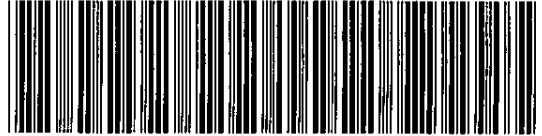

1. BE IT RESOLVED that Article VIII of the Articles of Incorporation be amended as follows:

ARTICLE VIII, DIRECTORS  
Number and Qualifications.

The Board of Directors shall be composed of not less than three (3) persons until such time as the Developer has conveyed title to all Units in the Condominium. The number of members of succeeding Boards of Directors shall be ~~from three (3) to seven (7)~~ five (5), ~~the actual number to be determined by a majority vote of the members present at a duly called meeting of the Association where a quorum is present...~~

WE HEREBY CERTIFY that the above Amendment to the Articles of Incorporation was approved by the Board of Directors and affirmative vote of not less than 75% of the total membership of this Association present in person and by Proxy (which is the sufficient number as required by the documents), at a Special Unit Owner Meeting, held on Tuesday, September 23, 2008, at 3:30 P.M. in Fountains Hall.
