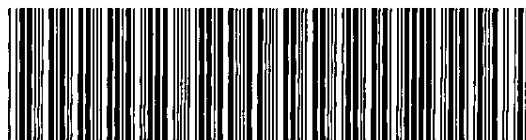

ARTICLE I - NAME

1 This corporation is organized for the purpose of transacting any or all lawful business.
