

I, the undersigned, acting as corporation, submit the following Article of Incorporation for the purpose of forming a non-profit corporation pursuant to Chapter 617 of the Florida Statutes, and hereby certify that:

# ARTICLE 1

The name of the corporation is Ministerio Internacional Encuentro con la Vida, INC. (hereinafter called the "Corporation.")

## **ARTICLE II**

The principal place of business and mailing address of the Corporation is 5088 Summit Blvd, West Palm Beach, Florida 33415 and the mailing address of the Corporation is 3526 Mountain Side Circle, West Palm Beach, FL 33406.

# **ARTICLE III**

This Corporation is a not-for-profit corporation, organized for the purpose of engaging in benevolent, charitable, social, and spiritual activities on a national and international level and for the purpose of engaging in any lawful act of activity not for pecuniary profit so which not -for-profit corporation may be organized, so far as is or may be permitted by the laws of the State of Florida and Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

## ARTICLE IV

Any person, corporation, partnership, association or organization, who is interested in the purpose of the Corporation, who is capable of contributing to the achievement of those purpose and the effective operation of the Corporation, and who complies with the requirements established from time to time by the Bylaws, shall be eligible for membership.

### ARTICLE V

The street address of the initial registered office of the Corporation is 3526 Mountain Side Circle, West Palm Beach, FL 33406; and the name of the

## **ARTICLE VIII**

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

### ARTICLE IX

No Part of the net earning of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting, to influence legislation (except as otherwise provided in subsection (h) of Section 501 of the Internal Revenue Code 1986), and the corporation shall not participate or intervene in (including the publishing or distributing) of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United State Internal Revenue Law)
